

Terms and conditions of use

PROSPECTIVA PARTICIPAÇÕES LTDA., a limited liability company, registered with the tax identification number under CNPJ No. 04.156.392/0001-33, headquartered at Avenida Brigadeiro Faria Lima, No. 201, Pinheiros, in the city of São Paulo/SP, Brazil 05426-100 (hereinafter, together with its affiliates and subsidiaries, referred to as "**Prospectiva**") sets forth these Terms and Conditions of Use ("**Terms**") of its website available through the URL www.prospectiva.com ("**Website**").

The purpose of these Terms is to regulate the rules for accessing and using the Website, as well as clarifying the rights, obligations, and responsibilities of anyone who accesses or uses the Website ("**User**").

By accessing and using the Website, the User declares to be aware of and agree with all the provisions of these Terms, being automatically bound by the rules established here. If the User does not accept these Terms, he must not access and use this Website.

1. GENERAL INFORMATION

1.1. Through the Website, Prospectiva makes available to the general public information about the company, services offered, places of operation, institutional information, as well as news and information related to the topic and scope of Prospectiva's activities, notably international public consulting and public affairs.

1.2. The provisions contained in these Terms bind Prospectiva as well as the Users, whose access, browsing, and use of the Website necessarily imply awareness and acceptance of these Terms. In case of disagreement by the User with the rules and provisions presented herein, the use of the Website must be immediately discontinued.

1.3. *These Terms may be amended at any time, at Prospectiva's sole discretion, without prior notice. The latest version of these Terms will always be available at: **www.prospectiva.com**. It is hereby agreed that such changes will apply to the Website from the moment the updated version of the Terms is made available on the Website.*

1.4. *The User must regularly review these Terms to ensure that they are aware of, understand and accept any changes made. Use of the Website following the posting of changes will indicate the User's acceptance of the updated version of the Terms.*

2. USE OF THE WEBSITE

2.1. The User may use the Website for informational and legal purposes only, and its use for commercial exploitation is prohibited. You may download and print content from the Website for personal use only and provided that all intellectual property rights are observed.

2.2. The User is strictly prohibited from using the Website and its content for commercial purposes, which includes:

- a. copy, record, download, or print any content on the Website for further redistribution, sale, or licensing upon receipt of fees;
- b. include any content on the Website in any work, which will be made available for sale or licensing, upon payment of fees;
- c. copy, download, or publish any content from the Website on another website or service that incorporates advertising with such content;
- d. use contents from the Website for promotional or advertising purposes, whether direct or indirect;
- e. use contents from the Website for the purpose of monetary gain through sale, resale, license, loan, rent, transfer, or any other form of commercial exploitation.

2.3. Additionally, the User may not:

- a. create content from the content made available on the Website, which does not comply with intellectual property rules;
- b. use any of Prospectiva's trademarks or logos without Prospectiva's prior written consent;
- c. misuse the Website by intentionally introducing viruses, trojans, worms, spyware, adware, or any other material that is malicious, technologically harmful or that may in any way affect the operation of the Website or any computer software or hardware related or connected to them.

2.4. If the User uses any content on the Website in violation of these Terms, the right to use the Website will cease immediately, and the User must return or destroy, at Prospectiva's discretion, any undue copies of the content without prejudice to civil and criminal liability.

2.5. Prospectiva does not guarantee that the Website will always be available or that access will be uninterrupted and error-free. Prospectiva may, at its discretion and at any time, carry out maintenance, remove or change content, as well as restrict access to all or any part of the Website.

3. NEWSLETTER OPT-IN AND RECEIPT

3.1. For browsing and use of the Website it is not necessary for the User to identify himself or herself. However, if he or she wishes to receive the Website Newsletter, a newsletter sent periodically by Prospectiva, the User must provide his or her e-mail address.

3.2. By providing his/her e-mail address as indicated above, the User expressly consents to the collection of his e-mail by Prospectiva for the specific purpose of sending a Newsletter. The User also agrees to periodically receive emails from Prospectiva with news and updates on topics of interest dealt with on the Website, including Prospectiva's advertising material.

3.3. If you no longer wish to receive these informative emails, the User may, at any time, request the cancellation of registration by sending a request to the email: contato@prospectiva.com

4. COOKIES AND OTHER TECHNOLOGIES

4.1. In order to optimize the User's browsing experience, the Website may use cookies and other browsing technologies. These technologies help recognize visitors, remember their preferences, as well as measure User traffic on the Website. Cookies also allow pages to load faster, facilitating browsing. By accessing the Website, the User may agree to the use of cookies and other browsing technologies under the terms of this Clause.

4.2. As with most websites, Prospectiva may automatically obtain browsing information such as the Internet protocol (IP) address used to connect your computer to the Internet, your geographic location, browser type, date, time and duration of your browsing, and logs. This information may be used by Prospectiva to understand and analyze trends, manage the Website, assess the behavior of Users, and obtain general

geographic information about users. Prospectiva may also use this information for purposes of security and improvements to the Website, as well as for marketing and advertising services.

5. PERSONAL DATA AND PRIVACY

5.1. When using the Website, the User may share with Prospectiva personal data, defined as information related to an identified or identifiable natural person ("Personal Data").

5.2. Prospectiva undertakes to keep all User Personal Data protected and confidential and guarantees that it will treat such Personal Data in accordance with the Privacy Policy.

5.3. The use of the Website by the User implies the User's consent to the Privacy Policy.

6. EXTERNAL LINKS

6.1. The Website may contain access links to other websites. The links are provided for the User's convenience and do not imply the approval or responsibility of Prospectiva regarding the external website or third-party content. The User is aware that when being directed to third-party websites, he or she will be subject to the specific terms of use and privacy policy of each website.

7. INTELLECTUAL PROPERTY

7.1. All content available on the Website, including, but not limited to, text, graphics, scripts, images, brands, logos, icons, photographs, editorial content, notifications, software, and any other material is the exclusive property of Prospectiva or is properly licensed by it, and may not be copied, plagiarized, reproduced, or published inappropriately in any media (whether physical or virtual).

7.2. The User may use content made available on the Website, provided that the use of the content does not violate any rules of intellectual property rights and does not have commercial purposes, subject to the provisions of Clause 2 of these Terms ("Use of the Website").

7.3. The User is prohibited from modifying, copying, distributing, transmitting, displaying, performing, reproducing, publishing, providing, licensing, or creating derivative works from information collected on the Website, for commercial purposes, under penalty of breach of this instrument and characterization of legal infringement.

7.4. The use of tools, scripts, software, robots or means that contain any virus, worms, malware, trojans, and/or other computer programs that may damage the Website and Prospectiva is expressly prohibited.

7.5. Any request for the use of content, brand logos, or images, or any other unauthorized use of intellectual property in these Terms should be emailed to: privacidade@prospectiva.com.

8. LIABILITY

8.1. The material available on the Website is provided for informational purposes. Prospectiva will make efforts to ensure that the information provided on the Website is complete, accurate, and up to date. However, the contents, whether prepared by Prospectiva or by a third party, are provided without any guarantees or representation as to their accuracy, completeness, or reliability.

8.2. As there are no infallible or inviolable security systems, Prospectiva is not responsible for any damage, injury, or loss of information caused by viruses or other technologically harmful material that may infect the User's equipment during use of the Website, nor for damages caused by the conduct of third parties, as well as in cases of force majeure.

8.3. To the extent permitted by law, Prospectiva disclaims any responsibility or liability for any direct or indirect loss or damage incurred by any User arising from the use of the Website and its content.

9. GENERAL PROVISIONS

9.1. The non-validity, in whole or in part, of any provision of these Terms shall not affect the validity of any other provision thereof, and Prospectiva is authorized to replace the provision declared void by one that reflects its real intention when drafting these Terms.

9.2 All matters involving Prospectiva and the User shall be governed by the laws of the Federative Republic of Brazil, herein electing the Court of the District of São Paulo/SP as the only competent authority to settle any disputes and/or claims that may involve the Parties regarding the use of the Website.
